About My Door Project

NOTE: Start your application early. You will need your Letter of Approval before you can begin your project. The Architecture Committee that reviews your project generally meets once each month, and the FHGC office requires some time for associated administrative functions.

Please submit this application form (pages 1 and 2) together with your photos and supporting documents to the Forest Hills Gardens Office. You may add additional pages to support/explain your project using the guidelines on the following pages.

Do not make any purchases, sign any contracts, or begin installation until you have your official Letter of Approval from FHGC.

Once you have your FHGC Letter of Approval and permit, you may begin your project. Share your Letter of Approval with your contractor so he may understand the full scope of your project and any specific requirements. Your contractor's contract should adhere to the conditions stipulated in your Letter of Approval.

Post your FHGC Permit in a prominent location while work is underway.

Application Reference and Guidance Information

Standards

- 1. Entry doors shall match the *original* architectural design of the door it replaces.
- 2. Full view storm doors, non-ornate security doors and multi-paneled garage doors are the predominate style of approved doors.
- 3. Traditional style hardware in a rubbed oil bronze finish is acceptable.
- 4. All garage doors must be constructed of wood; metal or any other non-wood material is unacceptable.
- 5. Entrance doors must be constructed of wood or in wood with aluminum cladding. French doors are an example that use these types of acceptable construction.
- 6. It is typical for older homes to contain non-standard sized openings. Therefore, all new doors must typically be custom sized. Note: No perimeter fillers of any kind are allowed.
- 7. Refer to the color palette assigned for your home, which you may obtain from the FHGC office, to determine the paint, aluminum clad or stain color of your door. Do not copy your neighbor's color or match the color you currently have as these may be inaccurate.

Submit the Following Information with Your Application


- 1. Specifications of the door and any other hardware planned for replacement such as door knob, mail slot, house numbers, door knocker, specialty hinges, etc. This includes dimensions and color.
- 2. If choosing to stain rather than paint a wood door, prepare a small section with the stain color in a semi-gloss finish on the door. An inspection by the Architecture Committee is required before final approval may be granted for all staining projects. Call the Office when a sample is available for inspection and to advise where the sample is located.
- 3. Photograph of the elevation of your home with the existing door planned for replacement.
- 4. If there is more than one door on that elevation, circle the door to be replaced.
